 - There was a lot on the November 8th ballot which may have caused some confusion and no votes – \$26.5 million bond received 51% no votes so still very close.
 - There is a lot of disappointment on social media from the school community that the bond and sinking fund did not pass. Our job is to advocate for what is best for students.
