We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2022-23 educational progress for Armada High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2022-23 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2022-23. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2021-22. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2022-23. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school was not given one of these labels

The 2022/23 school year was a continued return to pre-pandemic norms. Armada High School continued with Common Core Standards and curriculum alignment in all classes and continued to work to grow our learning opportunities for students. Staff continued to focus on evidence based instructional strategy implementation and aligning student learning outcomes to competency-based learning models.

- 1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL: Armada High School operates on a trimester schedule. Students are placed according to grade level curriculum credit requirements and student interests. In addition, NWEA, PSAT, and M-STEP assessments are used to assist in triangulating data and make informed decisions. All students who successfully complete 8th grade continue to Armada High School.
- 2. THE STATUS OF THE 3-5 YEAR SCHOOL IMPROVEMENT PLAN: Armada High School has developed an annual school improvement plan to close the achievement gap among our students in all the core teaching areas. Our school improvement plan targets the areas of math, reading and writing, grading and reporting practices, and relationships

IDENTIFY HOW TO ACCESS A COPY OF THE CORE CURRICULUM, A DESCRIPTION OF ITS IMPLEMENTATION, AND AN EXPLANATION OF THE VARIANCES FROM THE STATE'S MODEL: Armada High School utilizes Common Core Standards in both Mathematics and Language Arts. The Next Generation Science Standards (NGSS) and the state standards in social studies are being implemented in their respective courses, as well. THE AGGREGATE STUDENT ACHIEVEMENT RESULTS FOR ANY LOCAL COMPETENCY TESTS OR NATIONALLY NORMED ACHIEVEMENT TESTS: Armada High School uses the Northwest Evaluation Association assessment (NWEA), the Michigan Student test of Educational Progress (M-STEP), the ACT Workeys Assessment, and the SAT to measure student progress.

- 6. IDENTIFY THE NUMBER AND PERCENT OF STUDENTS REPRESENTED BY PARENTS AT PARENT TEACHER CONFERENCES. In the 2023/24 school year, there were approximately 565 students enrolled in Armada High School. We had 115 parents (20 %) take part in Fall conferences.
- 7. FOR HIGH SCHOOLS, ONLY ALSO REPORT ON THE FOLLOWING:
- a. THE NUMBER AND PERCENT OF POSTSECONDARY ENROLLMENT: 106 Armada High School students were enrolled in postsecondary courses. This is 18.7 % of Armada High School students. These students are enrolled in courses that are awarded credit through Ferris State University as well as Dual enrollment courses through Macomb Community College. This does not include our year 13 students that are enrolled in the Early College Program through Macomb Community College.
- b. THE NUMBER OF COLLEGE EQUIVALENT COURSES OFFERED: 14
- c. THE NUMBER AND PERCENTAGE OF STUDENTS ENROLLED IN COLLEGE EQUIVALENT COURSES: 159 students were enrolled in 1 or more AP courses; 159 28.1% of all students Grades 9-12
- d. THE NUMBER AND PERCENTAGE OF STUDENTS RECEIVING A SCORE LEADING TO COLLEGE CREDIT: In the 22/23 school year there were 277 AP tests given to 159 students. 165 or 59.5% of these tests received a score of 3 or higher.

Congratulations to the Armada High School family for their continued dedication and focus on providing the best learning environment possible for our students. We look forward to building on our successes and are dedicated to the process of continuous improvement.
