Superintendent's Report-Assisted by Student Representative

Superintendent Musary displayed some photographs: 1.) Two Armada High School are CTE Students of the Year. 2.) Armada Middle School National Junior Honor Society Induction. 3.) Three different traffic light options to be considered to provide extra safety for our Armada Center Road crosswalk between the Elementary and High School. In addition, the Superintendent with the assistance of the Student Representative provided the following updates:

- > Elementary Highlights—Mr. Sutton and his staff gave an update of the Krause Elementary happenings earlier.
- ➤ Middle School Highlights—The Middle School inducted 50 students into the NJHS, which is built upon scholarship, service, leadership, and character..
- ➤ MA²S Highlights by Student Representative—The Fighting Pi robotics practice course is nearly complete as the team is gearing up for their FIRST competition on March 1–3 at Oscar A. Carlson High School in Gibraltar. The FIRST State of Michigan Robotics Championship will be April 11-14 at Saginaw Valley State University. There are two FIRST World Championships this year and the one we are aiming for is at Cobo Centerl in Detroit on April 25-28.
- ➤ High School Highlights by Student Representative:
 - The High School play The Miracle Worker will be March 2 and 3 (7 p.m.) and March 4 (3 p.m.)
 - Two AHS wrestlers qualified for the MHSAA Division 2 Individual Wrestling Regionals: A junior (42-7) placed 2nd in the 189 bracket at Districts and a freshman (41-17) placed 4th in the 103

bracket at Districts. Nathan placed 4th at Regionals and qualified for the State Finals at Ford Field in Detroit on March 2-3.

- Armada High School hosted the Quiz Bowl on February 8th.
- The STUCO spread kindness last week for Random Acts of Kindness Week and handed out candy to students, decorated all lockers with a valentine, kindness clips and sticky notes throughout school, made a kindness board, and had a teacher appreciation day.
- The Girls Varsity Basketball Team will play their first MHSAA Class B District game on February 28th at Marysville High School. The team is 16-1 overall, 11-0 in the BWAC, and league champions. The Tigers are hosting Richmond tonight at 7:30 pm.
- The Boys Varsity Basketball Team will play their first MHSAA Class B District game on March 5th at Richmond High School vs. Richmond. The team is 13-2 overall, 9-1 in the BWAC, and in 1st place with a half lead over Richmond.
- AHS hosted a 13-team MHSAA Division 3 Competitive Cheer competition on February 16th and Armada placed 2nd and qualified for Regionals this Saturday at Flint Kearsley High School. In fact, there were 77 Division 3 teams that participated in Division 3 Districts and Armada had the second highest score of the 77 teams, so they are having a great season.
- The Snowcoming Dance was ironically cancelled due to too much snow. It has been rescheduled for March 17th and will now be a St. Patrick's Day dance.
- > Technology Update— The Krause Elementary School PA system and the cafetorium sound system are being updated. A security light system is being installed in the Middle School band room.

Curriculum Update

Assistant Superintendent Phil Jankowski provided detailed information about the following curriculum items utilizing an electronic report with active links so that the board (while using their new devices) can become familiar with the process of electronic board packs:

- PowerSchool Roadmap There is new functionality coming soon online for the PowerSchool Roadmap.
- PowerSchool Insights A single sign-on is coming soon. They are developing teacher, student, and a parent dashboard.
- MDE CBE Grant This Grant was submitted on February 12th in the amount of \$50,000 for teacher training, CBE Coach and community events..
- PLC Leaders The PLC leaders discussed some of the ideas we talked about in relation to the grant. They are trying to elicit input, stretch their thinking, and put the curriculum advancement out there for discussion.
- Instructional Model The 5E Model of Engage, Explore, Explain, Extend, and Evaluate was described.
- Tri-County Salary Survey Salary survey information for the tri-county area was provided.
- Extracurricular Activities Requirement Students that are involved in extracurricular programs do better and it builds a sense of belonging and pseudo-family structure.
- NWEA/M-STEP Correlation The tests align fairly significantly and encourages teachers to look at Projected Proficiency reports. He reviewed the data provided.

- 2.) Tami Seago asked various security questions. The Superintendent indicated that the staff has been trained by Homeland Security and have regular lock down drills. The Assistant Superintendent responded to a few question posed and mentioned that the building in question had a different layout, our district has access to Macomb Family Services, each building has student assistance team and they meet every other week, we have access to many county services noting that county services vary depending on where an individual lives, as well as other responses.
