#### Assistant Superintendent's Report

Assistant Superintendent Jankowski provided the following updates:

- ➤ Elementary Highlights—Students are beginning their innovation station/genius hour projects. On November 16th information was presented to K-2 parents on how to support literacy at home.
- Middle School Highlights—The first trimester Middle School Theatre Class just finished up a successful pilot with performances for the school on 11/15.
- > The Theatre Department hosted their Annual Craft Show on November 18th.
- The Choir performed at the Brown Iron for Veteran's Day.

- The Armada High School Theatre Department performed *The Addams Family* and were able to raise approximately \$1950 for St. Mary's Food Pantry. There were approximately 1200 seats sold between all five shows. There were 120 students involved, including 15 middle school students, and 1 elementary student.
- > Various upcoming events at each of the schools were provided.

#### **Presentations**

- 1.) Assistant Superintendent Jankowski introduced Students of the Month from Krause Elementary School (14 students), Armada Middle School (2 students), and Armada High School (2 students). They were each introduced and awarded with a Certificate.
- 2.) Student-Athlete Excellence Awards were presented to a Senior Girls' Golf Team member and three Cross Country Team members.

#### **Curriculum Update**

Assistant Superintendent Phil Jankowski provided detailed information about the following curriculum items:

- PowerSchool Unified Classroom Update—The Assessment Component Pilot is taking place; however, the parent/student portal is not ready.
- State Superintendent Whiston Visit—The State Superintendent will visit us on December 7th.
- Secretary Negotiations—Secretary negotiations will begin after Christmas break.
- MDE Proposed District Dashboard—The public input window is taking place for the MDE proposed district dashboard.
- The Governor's Education and Talent Summit—The Governor's Education and Talent Summit is taking place March 12 & March 13. Teach to Lead is taking place on March 12. The Education Excellence Dinner is scheduled for March 12. The Business & Education Combined takes place on March 13.
- Summit Learning—Applications are open for Summit Learning.
- Teacher Technology Survey Results—Mr. Jankowski reviewed the recent teacher technology survey results

#### Reports

The Student Representative reported on various activities at the High School.

Susan Nieman indicated that a Legislative Committee Meeting was held recently and highlighted items discussed. She stated that MASB is looking for someone from Region 8 (which is us) to run for the Board of Directors. Mrs. Nieman indicated that the big thing right now is concealed weapons in schools. She distributed a sample resolution that MASB sent out for the Senate bills that cover that. Mrs. Nieman indicated that the Senate has passed their portion and after Thanksgiving it goes to the House of Representatives and they tweak it and have a reconciliation to come up with a law. MASB is recommending that local school boards enact their policies in regard to weapons so that boards can be held accountable by their community.

### **Old Business**

1.) Cheryl Murray indicated that Sue Nieman, Scott Kline, and she went to the MASB conference. They learned a lot and there were motivational speakers and a trade show where numerous vendors were aware that we just recently passed a bond. 2.) Scott Kline asked if there are any updates regarding the lighted signs. The Assistant Superintendent indicated that not much progress has been made. Tami Seago asked if it would help if someone from the board could attend meetings. The Assistant Superintendent responded in the affirmative.

#### New Business

1.) Tami Seago indicated that John Paterek and the Fire Chief have committed to looking at the sustainability of the fire department plus the EMT program and have requested input at meetings to be held once per month.

- 2.) Tami Seago requested that we talk to three different management companies before we sign a contract for a construction manager for the bond project.
- 3.) A discussion took place regarding the subject of advertising and also not charging students to attend athletic events. Don Holston provided detailed information about gate receipts. Scott Kline indicated that he would like to see a proposal at the next workshop.

- T. Seago: 1.) Kurt Sutton and his team for providing information to the parents on literacy and being proactive.
- 2.) Robin (and her team) and how she continuously gives to our students. It is a tremendous amount of talent that she has to take the students from the beginning to where they are at now.
